Team Formation	Teams will be assigned after March 2, 2018 and you will be contacted by the coach regarding your first practice after the coaches meeting on Wednesday, March 7, 2018 . After teams have been formed there will be NO CHANGES MADE .
Siblings/Special Requests	Siblings will be placed on the same team. (At no additional charge) PARENTS MUST WRITE NAME OF SIBLING ON REGISTRATION FORM. Special requests will require an additional \$10.00 per child/ per request. (Must pay in full, financial assistance not applied to this amount.)
Games	Game times are dependent on the number of teams formed. Games can start as early as 9:00 AM with the youngest divisions playing first.
Practices	To be determined by the coaches. 1 practice per week for approximately 1 hour. You must be available to practice one time throughout the week: Monday - Friday, 4pm - 6pm. Special practice time requests are NOT guaranteed.
Required Equipment	All players must wear shin guards. Choice of indoor shoes, tennis shoes, or cleats.
Coaches Needed!	\$15 off your child's registration (plus the YMCA picks up a \$5.00 background check fee) if you volunteer to be a coach!
